


General Notes:

- 1. THE FOUNDATION IN THE DRAWING TO BE USED AS A MININUM GUIDELINE.
- 2. THE CONCRETE SHALL BE GRADE C25 (CHARACTERISTIC STRENGTH OF 3500 PSI AT 28 DAYS) MINIMUM.
- 3. THE FOUNDATION SHALL BE PLACED ON FIRM, UNDISTURBED SOIL SURFACE. WHEREVER EXCAVATION OCCURS BELOW THE DESIGNED FOUNDATION LEVEL, WELL COMPACTED BACK FILL OR LEAN CONCRETE SHALL BE USED FOR LEVELING.
- 4. BACKFILLING FOR FOUNDATION SHALL BE PLACED EVENLY IN LAYERS OF 6" (150mm) THICKNESS AND SHALL BE WELL COMPACTED.
- 5. THE FOUNDATION DESIGN IS SUITABLE FOR SOIL WITH A BEARING CAPACITY OF 1600 PSF (80 KPA) AND ABOVE.
- 6. THE FOUNDATION DESIGN IS SUITABLE FOR SOIL WITH FROST LINE OF 4' (1200 MM) OR LESS.
